However, there are some downsides to using this content that can impact student engagement and performance on tests. Synthetic content is created for instructional purposes and can often be predictable and formulaic, whereas authentic content includes texts from leading publications and primary sources that represent diverse perspectives and contemporary voices, addressing a variety of interests and learning styles. Additionally, ELA and literacy standards typically reference providing learners a rich diversity of high-quality, authentic literature from multiple genres and time periods. Synthetic, openly licensed, or public domain content may not meet those standards.
